Conditions of booking

- A booking is only secured when a deposit and booking form are received and acknowledged by us. If you cancel your booking (which must be in writing), for whatever reason, the deposit is forfeited.
- The balance of fees must be paid six weeks before the start of the booking. If you cancel your booking, for whatever reason, less than 12 weeks before arrival, 60% of the minimum group fee is due; if less than six weeks then minimum group fee is due.
- If a booking has to be cancelled by the centre and no acceptable alternative dates are available, all fees paid to the centre will be refunded; unless the cancellation is due to circumstances outside of FACT's control (e.g. Force Majeure).
- Should you have a change in circumstances, do contact the FACT office immediately; we will do all we can to accommodate your needs.
- FACT is covered by public liability insurance which indemnifies the Trust in the event of an accident or loss resulting from negligence on its part.
- Cancellation costs, personal accident and property loss for visitors is not covered, so we advise you to make your own arrangements if insurance is required.
- FACT has a Privacy Policy which can be found at www.fact.org.uk/privacy-policy or upon written request. Your data will be used and stored in accordance with this policy.

- Visitors are advised that they are not permitted to publish or make available to the public, images in any format, whether static or moving of the staff or volunteers of the Trust; or any organised activities, unless express permission has been granted in writing. Permission can be obtained by emailing info@fact.org.uk.
- Some FACT activities can be physically demanding. Participants should ensure that they have adequate fitness for the activities planned. FACT is keen to include everyone & will make every effort to adapt activities so all can participate safely.
- If conditions are unsuitable for the safe running of an event or activity, FACT will endeavour to offer a practical alternative to the advertised course or planned programme.
